RELEASE OF LIABILITY (please read)

In consideration for the present and any future use of, or presence at, FarmHill Equestrian Center, LLC's ("FarmHill's") facility, grounds, or events for the training, boarding, riding, or handling of horse(s) owned, leased, or in the undersigned's presence, including school horses ridden in lessons, **the undersigned hereby releases and forever discharges FarmHill** and its agents or employees (all of whom are hereinafter individually and collectively referred to as "FarmHill"), **from any and all claims, demands, actions, causes of actions, suits or causes of suits, whether in the nature of personal injury or property damage to the undersigned or to any minor child or legal ward of the undersigned**, arising out of the boarding, training, riding, participation, or auditing in any training, instruction, or other activities carried on at FarmHill or by FarmHill elsewhere.

The undersigned hereby acknowledges, understands, and assumes the special risks inherent in boarding, grooming, training, showing, breeding, transporting, riding, handling, or simply being in the presence of horses, and the costs and expenses of any injury or damage which may occur as a result of such horse-related activities. *The undersigned Participant or Legal Guardian of Participant also affirms that they are aware that falling from horses and/or riding horses and/or simply being around horses can cause physical harm, including neck, back, or other joint stress, and/or organ contusion, and/or other bodily harm. The undersigned Participant or Legal Guardian of Participant assumes all risk of injury, including the aggravation of any of the Participant's existing or pre-existing physical injuries and weaknesses, be they previously known or unknown, that could result from the Participant's activities at FarmHill, or activities put on by FarmHill elsewhere.*

The undersigned hereby declares that he/she **has read this Release** and FarmHill's Barn Rules, that this Release and the Barn Rules are fully understood and voluntarily accepted, and that to the fullest extent allowed by law **FarmHill shall not be liable for any personal injury, disability, or property damage which the undersigned, his/her child, or legal ward may receive or incur**. The undersigned **Participant or Participant's Legal Guardian** hereby further agrees to hold **FarmHill harmless and indemnify FarmHill from any payment for damages and from medical expenses** incurred in treatment of the undersigned or of his/her minor child or legal ward for injuries incurred while upon FarmHill premises, or elsewhere, in any capacity.
